**SUBJECT:** Regulatory Changes to Permanent Cosmetic Tattoo Curriculum and Performance Requirements

The Board for Barbers and Cosmetology has updated the curriculum and performance requirements for permanent cosmetic tattooing and master permanent cosmetic tattooing programs. **These new requirements will go into effect on January 5, 2026.** Permanent cosmetic tattooing schools must submit their updated curriculum documents by **April 1, 2026**. Schools that miss this deadline or fail to meet the new requirements will be considered out of compliance and will face administrative termination. Continuing to operate without an approved program may result in disciplinary action.

The following documents must be submitted to and approved by the Board in order to teach the updated curriculum:

1. A syllabus form (provided by the board)  
OR  
Updated syllabus complete with:
  - Course of study and hours of program
  - Textbooks used
  - Schedule
    - Days and times classes are held
    - Breaks to be given, as they cannot be counted towards the 1000 hours
    - If the course is full or part time. If one or the other is not offered, this must be specified
    - How long the program will take to complete in weeks
  - Online instruction information, if applicable
    - What topics are taught online — keep in mind only theory is allowed
    - What learning platform will be used
    - How long students will have to complete the online instruction
    - How student identity will be verified
2. A performance evaluation document (sample form provided by the board)
3. Course outline curriculum form (provided by the board)

All of the above **MUST** be submitted in order to be approved by the board. If you have both the basic and master programs, these documents must be submitted for each program respectively.

The Board has created and included several forms to assist you with providing the necessary information to be approved as quickly as possible. The use of these forms is not mandatory but will assist you with getting approval. If you choose not to use the forms, you must submit the required updated information in your own format. If desired, you can use the Board supplied forms for efficient approval and, at a later date, submit documents that reflect your school branding.

For your reference, the new curriculum requirements and FAQs concerning the updated curriculum are enclosed. The permanent cosmetic tattooing curriculum changes will also be uploaded to the DPOR website, the Virginia LIS (legislative information system) website, and the Virginia Townhall website.

  - d. Preparing station, making appointments, and salon ethics:
    - (1) Maintaining professional appearance and notifying clients of schedule changes; and
    - (2) Promoting services of the salon and establishing clientele; and
  - e. Salon management:
    - (1) Licensing requirements; and
    - (2) Taxes.

  - b. Contraindications and when not to perform services;
  - c. Skin tones;
  - d. Color selection and skin tone matching;
  - e. Scars;
  - f. Burn scars; and
  - g. Common needle configurations used for camouflage.
12. Side effects - **minimum of five hours of instruction.**
13. Insurance - **minimum of five hours of instruction.**
14. Master permanent cosmetic tattooing procedures - **minimum of 110 hours of instruction:**
- a. Lip;
  - b. Areola;
  - c. Blush;
  - d. Camouflage; and
  - e. Eyeshadow.

D. A minimum of 55 performances must be completed as part of the master permanent cosmetic tattooing instruction, including:

Lip (cleft lip repigmentation)	five performances
Areola	10 performances
Blush application	10 performances

Eyeshadow	10 performances





## Tattooing & Permanent Cosmetic Tattooing Curriculum Update - Frequently Asked Questions

---

**Q: What exactly is changing?**

**A:** None of the curriculum *topics* are changing. However, each topic is now assigned a specific number of hours within the curriculum. Same topics, new hours of instruction. For permanent cosmetic tattooers, the performance requirements have increased and are now completely defined.

**Q: When do these changes become effective?**

**A:** January 5<sup>th</sup>, 2026

**Q: I already have students enrolled, how will these changes affect them?**

**A:** Students enrolled in one of the affected programs before January 5<sup>th</sup>, 2026, will have to either:

1. Finish the program they started:
  - a. Students must complete the tattoo program by December 31<sup>st</sup>, 2026
  - b. Students must complete the permanent cosmetic tattoo program by June 30<sup>th</sup>, 2026.
  - c. Students must complete the master permanent cosmetic tattoo program by June 30<sup>th</sup>, 2026.

**OR**

2. Transfer to the new program

Whether transferring will benefit the student or not must be evaluated on a case-by-case basis. For example, a student who is nearly done with their program would not benefit from a transfer compared to someone who just started, or who may need to take a leave of absence. If a student can reasonably finish by the deadline, they should be fine without a transfer.

**Q: Will graduates trained under the requirements effective before January 5<sup>th</sup>, 2026, still be eligible to sit for the state board exams?**

**A:** Yes, as long as the program they completed was board-approved and in effect when they started it.

**Q: What happens if a school does not have the new program approved by the effective date?**

**A:** Schools without a new program approved by the board will not be able to enroll new students after the effective date. This is because after the effective date, the old programs will not exist.

**Q: I am a school, what do I need to do?**

**A:** New documentation will be required. All schools will be receiving an update packet via USPS Certified Mail and email containing information about the update, as well as a complete list of what to submit.

**Q: When do I need to submit the new required documentation?**

**A:** New documentation must be submitted to the Board by April 1, 2026. Schools that miss this deadline or fail to meet the new requirements will be considered out of compliance and will face administrative termination. Continuing to operate without an approved program may result in disciplinary action.

**Q: When may I begin teaching the new curriculum?**

**A:** Schools may begin offering the new curricula once their required documents have been approved by the Board.
